7. Schedule V is amended in the **Method of measurement** Division

- (1) by replacing "- 50° " in subparagraph 1 of the first paragraph by "- 5° ";
 - (2) by adding the following paragraph at the end:

"The WBGT values may also be measured using a direct-reading measuring instrument.".

2. Section 5 is amended

- (1) by replacing "under" in the first paragraph by "in accordance with";
 - (2) by replacing the third paragraph by the following:

"The minimum content of the kit in vehicles not covered by the second paragraph is the content provided for in clause 5.3 of CAN/CSA Standard Z1220-17, First aid kits for the workplace."

The draft Regulations harmonize seven regulations with provisions respecting hazardous products. In 2015, the Act to enhance the communication of hazard-related information concerning products present in the workplace and to amend the Act respecting occupational health and safety (S.Q. 2015, chapter 13) was made to harmonize the provincial legislation with the federal legislation with respect to hazardous products. The migration to SIMDUT 2015 changed the method for classifying products and it provides new terminology to describe hazard classes.

Consequently, the draft Regulations amend the terminology to preserve the meaning and scope of the regulatory provisions concerned, maintain the protection level currently available for workers and maintain the current requirements in enterprises.

The impact of the amendments to the Safety Code for the construction industry (chapter S-2.1, r. 4), the Regulation respecting safety representatives in establishments (chapter S-2.1, r. 12), the Regulation respecting prevention programs (chapter S-2.1, r. 10), the Regulation

respecting health and safety committees (chapter S-2.1, r. 5), the Regulation respecting occupational health services (chapter S-2.1, r. 16), the Regulation respecting occupational health and safety (chapter S-2.1, r. 13) and the Regulation to amend the Regulation respecting safety and health in foundry works (chapter S-2.1, r. 15), will not entail compliance costs for enterprises since they do not anticipate any additional requirement.
