Order number 2022-006 of the Minister of Education dated 30 August 2022

Education Act (chapter I-13.3)

CONCERNING the Regulation to amend the Regulation respecting certain conditions of employment of senior executives of school service centres and of the Comité de gestion de la taxe scolaire de l'île de Montréal

THE MINISTER OF EDUCATION,

WHEREAS in and by section 451 of the Education Act (chapter I-13.3);

WHEREAS the Regulation respecting certain conditions of employment of senior executives of school service centres and of the Comité de gestion de la taxe scolaire de l'île de Montréal was made by the Minister's Order dated 18 November 2004 approved by the Conseil du trésor on 30 November 2004 (C.T. 201768), and as amended;

WHEREAS it is expedient to amend the current Regulation and to make the Regulation attached hereto;

WHEREAS, pursuant to section 451 of the Education Act, the Conseil du trésor has given its authorization;

WHEREAS the Regulations Act (chapter R-18.1) does not apply to such a Regulation;

ORDERS THAT:

The Regulation to amend the Regulation respecting certain conditions of employment of senior executives of school service centres and of the Comité de gestion de la taxe scolaire de l'île de Montréal, herewith attached, be made.

Regulation to amend the Regulation respecting certain conditions of employment of senior executives of school service centres and of the Comité de gestion de la taxe scolaire de l'île de Montréal¹

Education Act (chapter I-13.3, s. 451)

- **1.** Section 24 of the Regulation respecting certain conditions of employment of senior executives of school service centres and of the Comité de gestion de la taxe scolaire de l'île de Montréal is amended by replacing the first two paragraphs with the following:
- **"24.** A senior executive is entitled to additional remuneration of 1.5% of the salary received from 1 April 2019 to 31 March 2020.

A senior executive is entitled to additional remuneration of 1.00% of the salary received from 1 April 2020 to 31 March 2021.".

- **2.** Section 33 of the Regulation is replaced with the following:
- **"33.** A senior executive's salary scales and salary shall be increased by:
 - (1) 2.00% from 1 April 2020 to 31 March 2021;
 - (2) 2.00% from 1 April 2021 to 31 March 2022;
 - (3) 2.00% from 1 April 2022 to 31 March 2023.

The salary scales are found in Schedule 3.".

3. Schedule 3 of the Regulation is replaced with the following:

Regulation to amend the Regulation respecting certain terms of employment applicable to officers of agencies and health and social services institutions

THE MINISTER OF HEALTH AND SOCIAL SERVICES,

CONSIDERING the first paragraph of section 487.2 of the Act respecting health services and social services (chapter S-4.2), which provides in particular that the Minister may,

by regulation, determine the standards and scales which must be used by agencies, public institutions and private institutions under agreement for the selection, appointment and engagement of and the remuneration and other terms of employment applicable to senior and middle management personnel;

CONSIDERING that the Regulation respecting certain terms of employment applicable to officers of agencies and health and social services institutions (chapter S-4.2, r. 5.1) has been made;

CONSIDERING that it is expedient to amend the Regulation;

CONSIDERING the authorization obtained from the Conseil du trésor in accordance with the third paragraph of section 487.2 of the Act respecting health services and social services;

CONSIDERING that it is expedient to make the Regulation to amend the Regulation respecting certain terms of employment applicable to officers of agencies and health and social services institutions;

ORDERS AS FOLLOWS:

The Regulation to amend the Regulation respecting certain terms of employment applicable to officers of agencies and health and social services institutions, attached to this Order, is hereby made.

Regulation to amend the Regulation respecting certain terms of employment applicable to officers of agencies and health and social services institutions

Act respecting health services and social services (chapter S-4.2, s. 487.2)

1. The Regulation respecting certain terms of employment applicable to officers of agencies and health and social services institutions (chapter S-4.2, r. 5.1) is amended in section 9 by adding the following paragraph at the end:

"In addition, any adjustment or other form of increase provided for in this Regulation applies only to the terms of employment of officers determined in the Regulation and, consequently, such adjustment or increase does not apply in particular to any measure taken by ministerial order under section 123 of the Public Health Act (chapter S-2.2) under the public health emergency declared by the Government under Order in Council 177-2020 dated 13 March 2020."

- **2.** Section 12 is amended by replacing subparagraphs 1 to 3 of the first paragraph by the following:
- "(1) for the period from 1 April 2020 to 31 March 2021: 2.0%;
- (2) for the period from 1 April 2021 to 31 March 2022: 2.0%;
- (3) for the period from 1 April 2022 to 31 March 2023: 2.0%.".
- **3.** Section 12.0.2 is replaced by the following:
- "12.0.2. An officer receives an additional remuneration corresponding to 1.0% of the salary received for the following periods:
 - (1) from 1 April 2019 to 31 March 2020;
 - (2) from 1 April 2020 to 31 March 2021.".
- **4.** Section 12.1 is amended by replacing "the lump sum provided for" in the third paragraph by "the additional remuneration provided for".

- **"28.2.** A senior administrator receives an additional remuneration corresponding to 1.0% of the salary received for the following periods:
 - (1) from 1 April 2019 to 31 March 2020;
 - (2) from 1 April 2020 to 31 March 2021.".
